Entertainment Condition of Sale and Entry

The following are Conditions of Sale (including any resale or subsequent assignment):

- Tickets may only be used by the holder to gain admission to the relevant exhibition and may not, without prior written consent of MGM, be resold or offered for resale at a premium (including via on-line auction sites or social media sites) or used for advertising, promotion or other commercial purposes (including competitions and trade promotions) or to enhance the demand for other goods or services, either by the original purchaser or any subsequent bearer. If a ticket is sold or used in breach of this condition, the ticket may be cancelled without a refund and the bearer of the ticket may be refused admission, without prior notification. Entry may be refused if tickets are damaged, defaced, forged or copied in any way or are not purchased from MGM or other authorized points of sale.
- 2. All ticket sold and issued are final. Except pursuant to clauses number 3 below, 7 and 8 under Sales Policy, all completed and confirmed transactions cannot be cancelled, and are non-refundable and non-exchangeable for any reason, including but not limited to the ticket purchaser's travel to and from the exhibition venue due to the alteration, late arrival, unavailability, postponement or cancellation of travel services. MGM is not liable for any lost, stolen or destroyed tickets.
- 3. MGM reserves the rights to charge a fee for the replacement of tickets, and reserves the right not to replace tickets where seating is not allocated (general admission tickets) or if customer details cannot be verified.
- 4. The right of admission is reserved and all ticket holders are subject to the *Entertainment Condition* of Sale and Entry, available at <u>tickets.mgm.mo</u> or upon request.
- 5. Cameras, photo taking, audio and video recording for commercial use are not permitted inside the venue, unless previously authorized by MGM. Admission to premises constitutes your agreement to be photographed, filmed, videotaped or otherwise recorded in connection with the exhibition and your agreement that your name, voice and likeness may be broadcasted, distributed or displayed in connection with any program created from the performance without any compensation being paid to you.
- 6. By using this ticket, the ticket holder acknowledges that she/he has reviewed the Privacy Policy available at tickets.mgm.mo and agrees with its terms.
- 7. Macao law shall govern the sale of all tickets and you agree to submit any dispute that may arise to the exclusive jurisdiction of the Macao courts.

Exhibition Terms and Conditions

Sales Policy

- MGM reserves the right to restrict the sale of tickets to a maximum number per person, per credit
 card and/or per household and to cancel any tickets purchased in excess of the set number. For
 enquiry about the maximum number purchase, please visit the exhibition page in tickets.mgm.mo,
 call customer care hotline or enquire at all MGM box offices.
- 2. Ticket prices and discounts may change during a sale period, as determined by MGM.
- All will-call tickets must be collected before the visiting date or appointed date of pickup. MGM
 will not retain any uncollected tickets after the appointed visiting date. No refunds will be made
 for uncollected tickets.
- 4. To collect tickets at the box office, the cardholder must present the credit card used to book the tickets and a valid photo ID as identification. MGM will not be liable for any responsibility once the tickets are collected.
- 5. Complimentary tickets are not eligible for cash refunds. In the event of cancellation or postponement of an exhibition, holders of complimentary tickets should contact the department that has offered the ticket for an exchange of ticket, if applicable.
- 6. For any exhibition cancellation or postponement announced before the exhibition starts, MGM shall only be responsible for refunding the cost of ticket(s) or exchange tickets at the same price. Refunds will be handled as per the original purchasing method within 30 days. MGM shall have no further liability to customers beyond the face value of the ticket purchased. Any refund shall be made to the holders of the authorized / valid tickets only. The abovementioned responsibility only applies to tickets which have been sold by MGM.
- 7. MGM will not be responsible for any refund or exchange if exhibition cancellation occurs after 45 minutes of the session starts.

Entry Policy

- 1. One ticket per guest (11 years old and up). All guests are liable to be searched or to be asked for proof of a valid exhibition entry by authorized personnel at any time. Failure to submit will result in a refusal of admission and may also constitute a ban from the exhibition.
- 2. Free entry for child aged 10 or below accompanied by an adult.
- Courteous behavior is expected. Appearing intoxicated, using foul/abusive language, or displaying
 overt rowdiness will not be tolerated; transgressors will be ejected from the exhibition without
 refund or compensation. If you notice concerning behavior, please notify us immediately.
- 4. Unauthorized soliciting, selling goods, or conducting surveys is prohibited. These actions will result in ejection from the exhibition without refund or compensation.
- 5. Photography and audio/video recordings are encouraged, but flashlights, tripods, and selfie sticks will not be permitted.
- 6. Do not damage or deface any facilities.
- 7. Do not run inside the exhibition.
- 8. To maintain a quiet and immersive environment, phone calls and loud noises are not permitted.
- 9. Baby strollers are not allowed inside the exhibition; if you have a stroller, please consult an onsite staff for more information.
- 10. Storage lockers will not be provided.
- 11. Guests are solely responsible for their own belongings. MGM will not assume liability for any damage to or loss of guest property.
- 12. Please use the restroom before entering; there are no facilities within the venue.
- 13. MGM reserves the right to amend the opening hours at any time.
- 14. MGM reserves the right to remove any exhibit from the exhibition at any time.
- 15. MGM reserves the right to refuse admission or to remove guests from the venue if the exhibition's rules are not adhered to.
- 16. The guest shall indemnify MGM against all actions, claims, and demands by any person who suffers or sustains any injury, loss, damage, or death arising from or as a result of negligent use of the facilities.

17.	MGM may photograph, film, videotape, record, or otherwise reproduce the image and/or voice
	of any person who enters the exhibition. The result may be used for any purpose without payment
	to any person.

18. MGM reserves the right to make final decisions in the case of any disputes.

Exhibition Policy

- 1. The exhibition halls will be closed if Tropical Cyclone Warning Signal No. 8 or above, Black Rainstorm Warning Signal, or Extreme Condition Signal is issued.
- 2. MGM reserves the right to change the advertised exhibition date and schedule of exhibition without notice.
- 3. MGM will not be liable for any delay or cancellation due to any force majeure such as power failure, fire, explosion, flood, typhoon Signal No. 8 and above, storm or similar disasters, strikes, industrial disputes, abnormally inclement weather, war, insurrection, riot, civil disturbance, acts or threats of terrorism, act of God, communicable disease outbreaks, industrial action, acts or regulations of national or local governments, governmental order or decrees, or any other cause beyond its reasonable control.

Prohibited Items Policy

- 1.
