## **Note and Admission Instructions:**

- 1. The event is suitable for all ages. Children aged 10 or below must be accompanied by an adult at all times.
- 2. Entry closes 15 minutes prior to the daily closing time.
- 3. Consumption of food and beverages, and smoking is strictly prohibited within the venue.
- 4. Food, beverages, hazardous materials, or sharp objects are not permitted inside the venue.
- 5. Pet Policy (Applicable to Indoor Areas of Barra District):
  - Pets must be properly restrained to avoid causing disturbance to other guests.
  - To ensure a positive experience for all visitors, the following regulations apply to dogs, cats, and other animals entering indoor exhibition areas:
    - Size Classification:

Small dogs: Under 40 cm in height
Medium dogs: 40–60 cm in height
Large dogs: Over 60 cm in height

- Small and medium-sized dogs, cats and other animals must be secured in a pet stroller and leashed with a restraint no longer than 1.5 meters. Free roaming indoors is prohibited. If you do not have a pet stroller, you may borrow one from the Information Counter located at the Barra District iCenter.
- Large dogs must be muzzled indoor at all times (exemptions apply to dogs with a valid green license) and leashed with a restraint no longer than 1.5 meters.

- Pets must show no signs of illness and may not be left unattended. Disruptive behavior (e.g. causing nuisance to others or damaging property) is strictly prohibited.
- Dogs must be licensed and leashed (≤1.5 m) in both indoor and outdoor areas.
- Other animals must be confined to pet carriers, cages, or boxes at all times.
- Pets are prohibited in areas marked "No Animals Allowed" (service animals are exempt).
- Owners are liable for cleaning fees if pets soil public areas; violations will be reported to authorities.
- 6. Inclement Weather Policy:
  - Typhoon Signal No. 1, No. 3 or Amber/Red/Black Rainstorm Warning:
    - The exhibition remains open.
  - Typhoon Signal No. 8 or Above:
    - The exhibition closes immediately.
    - If the signal is lifted ≥2 hours before opening, the exhibition resumes as scheduled.
    - o If the signal is lifted <2 hours before opening or during operating hours, the exhibition reopens within 2 hours of cancellation.
    - o If the signal is lifted after 3:00 PM, the exhibition remains closed for the day.
- 7. Guests will be held financially responsible for any damage to exhibits or facilities.
- 8. Attendees must adhere to venue regulations and staff instructions. Queuing is required during peak hours.
- 9. The organizer reserves the right to eject any individual for misconduct without refund or recourse.
- 10. Event details and facilities are subject to change without prior notice.
- 11. The organizer retains absolute discretion over all matters.
